Notes:

The famous French designer Pierre Cardin, who created an iconic brand in his name, recently passed away at the age of 98. He licensed thousands of products in his name and they were sold across over several outlets worldwide. Beyond his designer clothes, he also licensed products like Perfumes, Makeup, Porcelain, Chocolates among others.

Union Minister of Health and Family Welfare Harsh Vardhan has been nominated by the Global Alliance for Vaccines and Immunisation (GAVI) as a member on the GAVI Board. The Minister is to succeed Mr. MyintHtwe of Myanmar and will represent the South East Area Regional Office (SEARO)/ Western Pacific Regional Office (WPRO) constituency from 1st January 2021 until 31st December 2023.

The National Pension System (NPS) was implemented with effect from the 1st January, 2004. It was extended to all citizens of the country from 2009 on a voluntary basis. PFRDA regulates the National pension system (NPS) as well as the pension sector.

This practice falls under the Maharashtra Prevention and Eradication of Human Sacrifice and other Inhuman, Evil and Aghori Practices and Black Magic Act. A petition was filed to prevent advertisements that promote the sale of articles like Hanuman Chalisa Yantra.

The unit is made up of stainless-steel body that has a carrying capacity of 2280 passengers. BMEL has obtained orders for manufacture of 576 such cars for Mumbai Metropolitan Region Development Authority (MMRDA)'s MRS1 project.

Recently, annual BouddhaMela was celebrated in the Buddhist heritage site, which is generally celebrated a day after Sankranti festival.

The index lists 26 indicators on five dimensions namely water, sanitation, housing,

micro-environment, and other facilities. It also classifies the regions in three levels of access to bare necessities namely high, medium, low.

A house-to-house surveillance will also be provided to vaccinate the remaining children.
